Announcements

Members represent all four schools as well as have knowledge of both undergraduate (CUCAS) and graduate (Graduate Council) programs. Background: Last fall at CUCAS, Dr. Missy Alexander discussed having a centralized repository for all University standing committees where various records, reports and documents associated with those bodies would be updated in a timely fashion and would be accessible to faculty and staff. Currently, that does not exist. Some committees, such as CUCAS, have websites that are constantly updated with documents (minutes, agendas, meeting times and locations, members, etc.). Other committees have outdated websites. Some have no website. Over the past months, Dr. JC Barone has met with Dr. Tom Philbrick, University Senate President, and Ms. Veronica Kenausis, Director of the Library to discuss and explore ways to do this. The Senate is the logical body to organize and oversee this. Through current efforts by V.P. Jennifer O'Brien, the Senate is undertaking organization of such information. Dr. Philbrick stated he is looking into the status of this effort. Barone wants to move this effort forward in a timely fashion.
