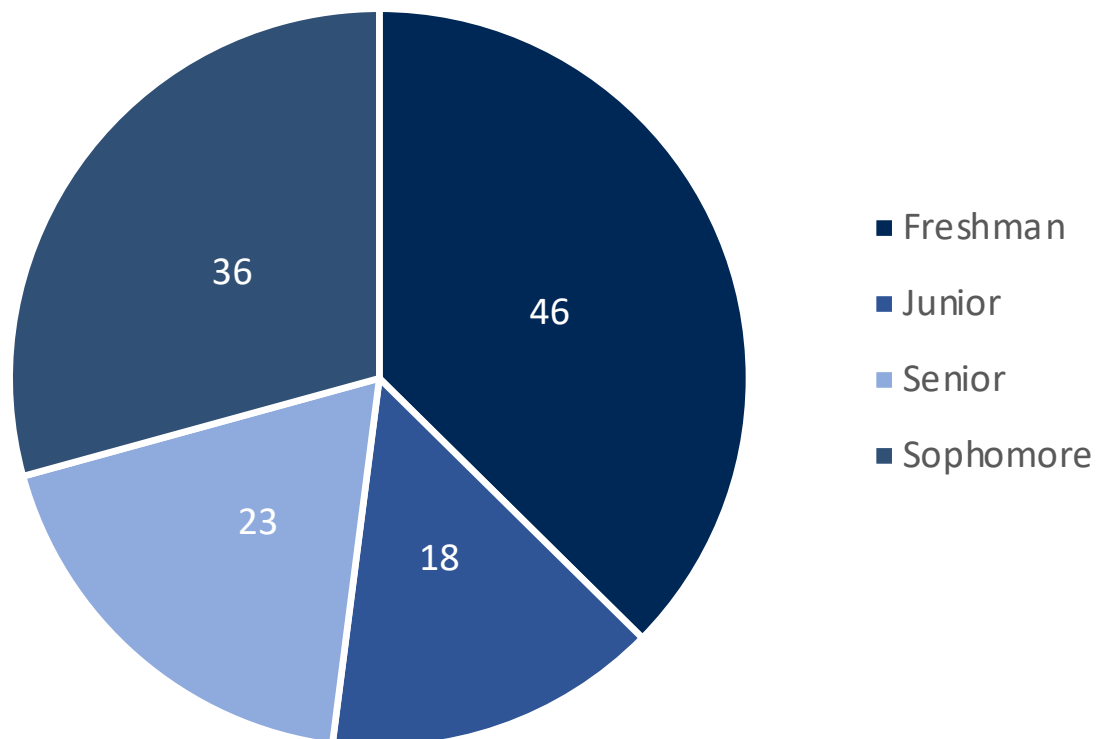

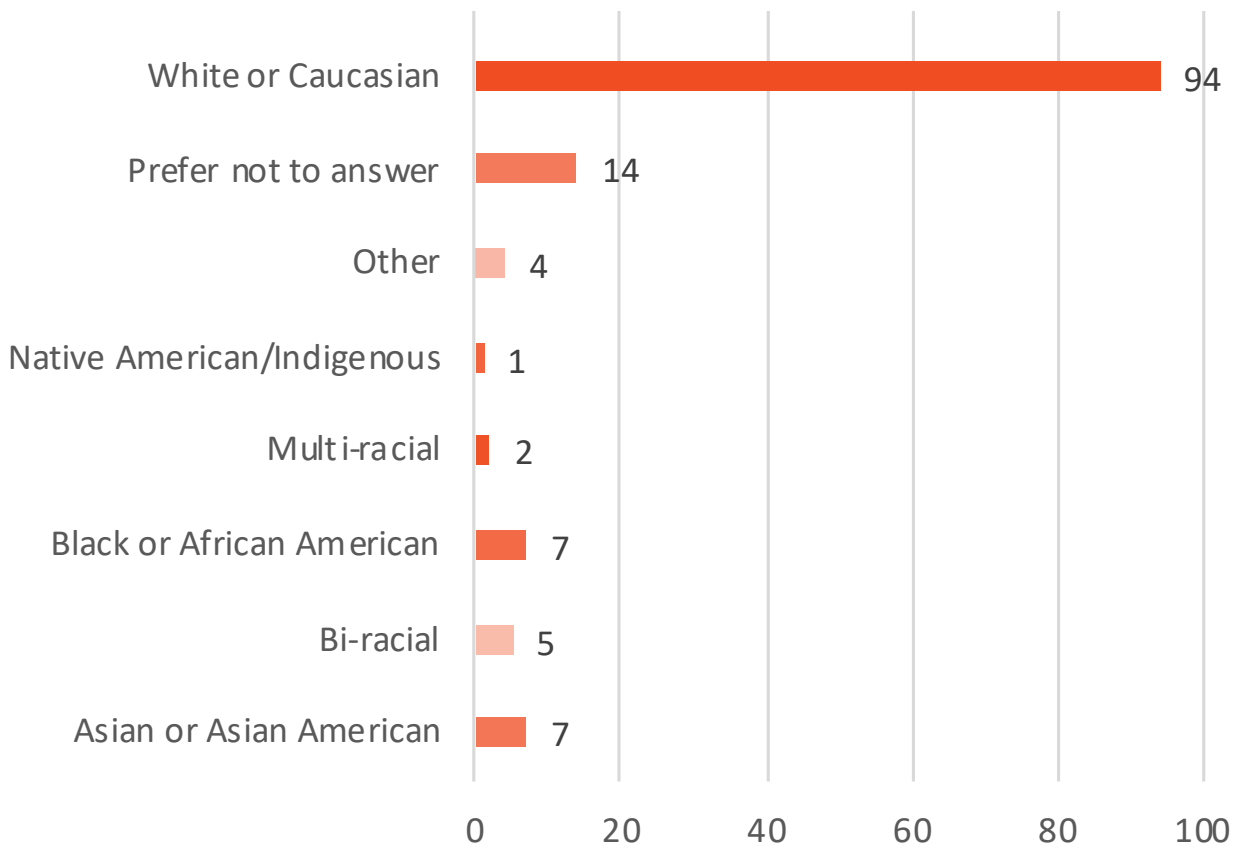

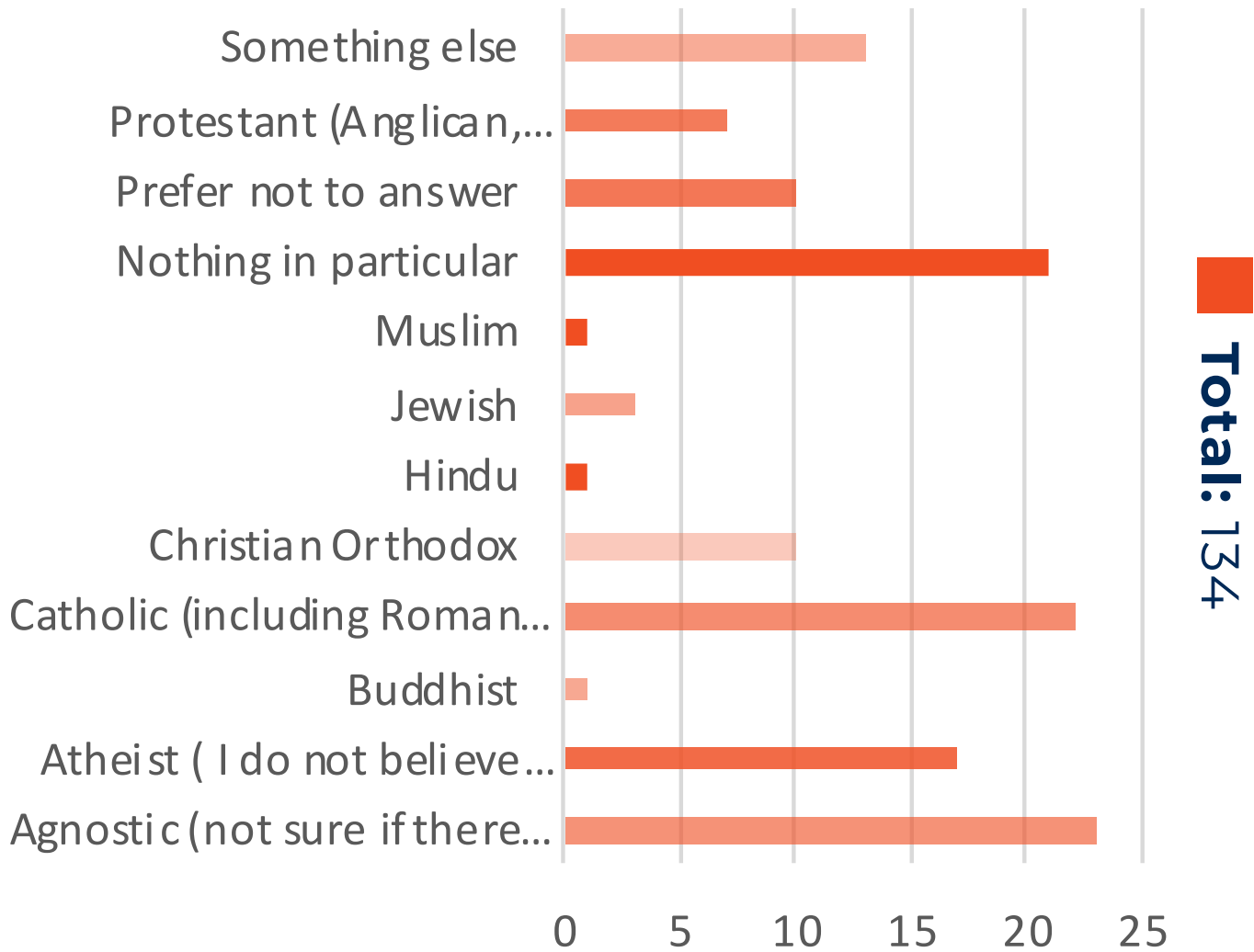

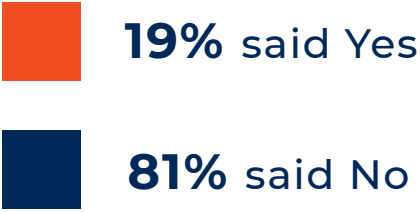

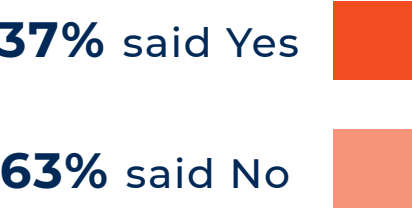

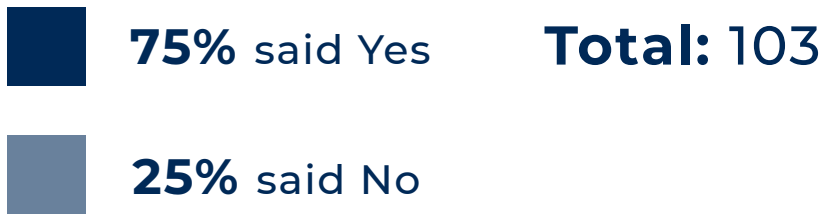

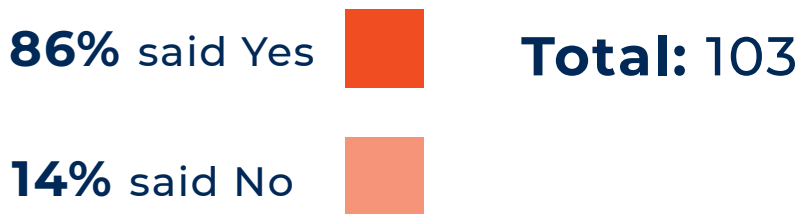

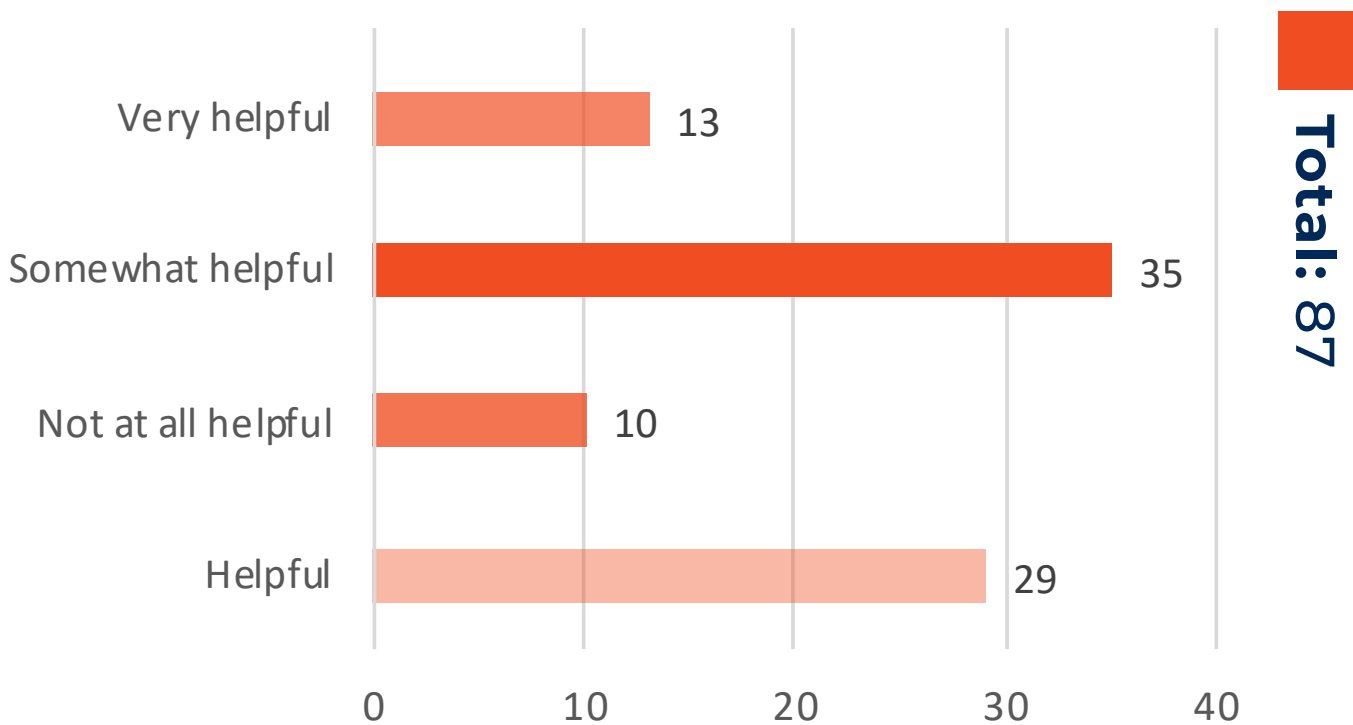

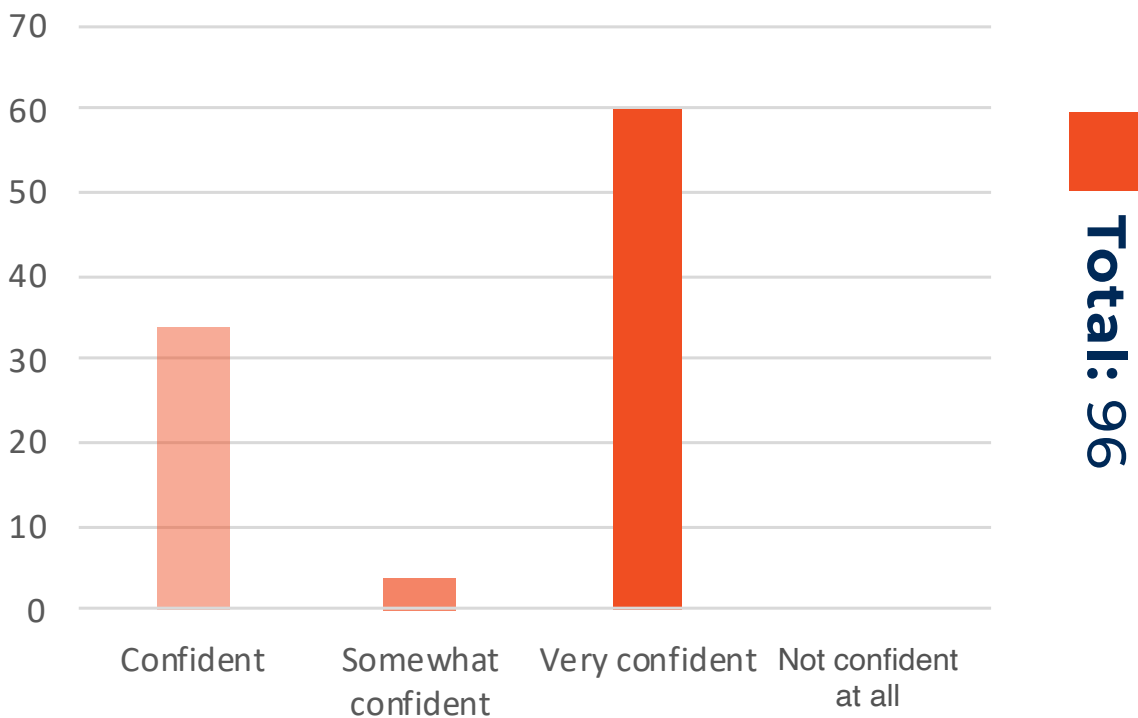

# Please tell us, in your own words, what constitutes clear consent?

Verbal, articulate consent by both parties in a sober and healthy state of mind.

A "no", "I'm not comfortable" or similar response to this, and specific body language. Anything but a yes is a no and that's what constitutes clear consent.

Continuous and explicit agreement made of free will

A person clearly stating in words that they are okay with whatever is happening, or clearly demonstrating reciprocity.

Sober, Yes, Comfortable

the word yes

enthusiastic "yes"

a for sure yes

using your words to make sure the other party is clearly ok with what is going on.

a clear and enthusiastic YES to whatever activity is going on from both parties involved.

A sober verbal yes after being asked multiple times if moving forward was okay.

Clear consent is an enthusiastic "yes."

Situational.

Asking someone if they are okay with something you want to do with them, respecting someone's boundaries, and making sure someone is conscious when they answer are all what constitute clear consent.

One or more people agreeing (verbally saying yes with clear associating body language) to do any activities (sexual or non)

Verbal agreement after verbal request to have intimate contact with partner's intimate areas

They say they consent

A sober agreement to do something sexual together with clear boundaries

Making sure the other person is comfortable/ agrees

A clearly-voiced agreement and understanding of boundaries between two or more individuals partaking in a sex act.

you have to verbally consent

# Please tell us, in your own words, what constitutes clear consent? Cont.

clear, sober yes. all parties are willing and able to perform at their own pace and the ability to stop at any time.

A freely given, affirming yes (should not be a wishy-washy/unsure answer, more of a resounding/confident yes)

Clear consent is a freely given, informed, enthusiastic, and explicit agreement to engage in an activity, communicated through words or actions that leave no doubt.

Yes in a verbal or non verbal conversation where both parties mutually agree and are willing to do something together.

Without a shadow of a doubt a 100% clear "yes" not under the influence of intoxicants

Clear consent is when someone gives another person a verbal and definitive "yes" to do anything with them

Sober stating yes.

Sober, clear, NO.

a clear, "yes", anything else should be taken as a no

When you verbally ask a person yes or no before anything sexual happens and if they ask you to stop you stop

An enthusiastic yes from both parties

Either verbally communicating consent such as outright saying "Yes" to advances and sometimes bits of nonverbal communication like a nod

A clear, sober Yes or No.

Asking continuously if it's ok for someone to do something sexual to you while sober

Enthusiastic agreement

When both parties say yes and both are willing to do it.

Person verbalizes consent in words. It is not assumed by action or inaction.

If someone simply doesn't say yes don't do anything else.

The word yes.

# Please tell us, in your own words, what constitutes clear consent? Cont.

Clear consent is when both parties have a verbal agreement to engage in sexual activity.

A clear, enthusiastic, verbal yes. It can also be revoked at any time at any stage.

Asking for permission first

Enthusiastic verbal consent from all participating members, repeatedly and throughout the sexual act.

Consent is to say "yes" with zero hesitation. If any uncertainty or discomfort is present, that automatically means "no".

A verbal answer that is yes with no filler words such as umm. The person has to say yes and their body language has to agree with what they are saying. So if they are closed off for their body language and say yes that would be interpreted as a no.

Asking someone for permission to make sure they are okay with what we do around them.

A affirmative VERBAL yes in response to what you are asking for permission to do

If, and only if, the other person in the relationship clearly says yes to or approves of a sexual interaction would that be considered consent.

an individual agrees to something

Sober, non pressured agreement between both parties y hat don't cross clear and discussed boundaries

when you ask the person if you what to kiss but they tell you no and you didn't do it.

Given concent to do anything without being pressured or forced to do somehting uncomfortable

a confident and excited "yes"

Verbal agreement on something from all parties involved. Can be described as an enthusiastic agreement to something. VERBAL, through WORDS.

When the person is comfortable and feels safe

A verbal conformation that wasent pushed out of them or given because the person feels obligated

Whether or not someone says "no" to something, and you have to respect that. Whether it's in non-verbal communication or in a non sexual setting, too.

Clear consent is expressed in a way where there is no doubt in both (or more) parties response, this includes intoxication.

Saying yes when asked to engage in a sexual activity and agreeing to sexual acts very clearly

clear consent is when both people are willing participants.

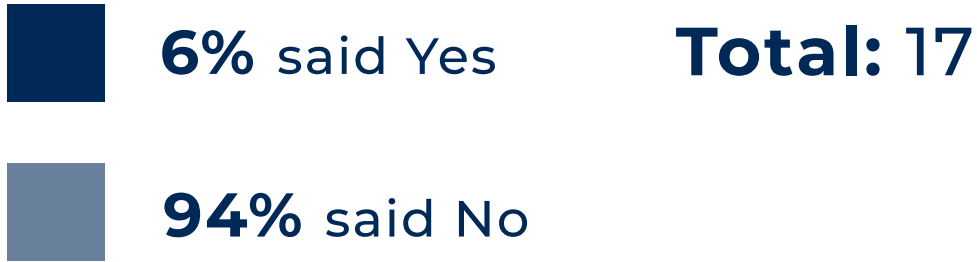

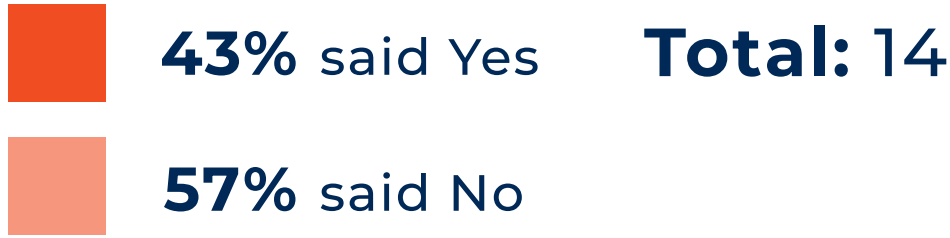

According to CT Law, the victim/person reporting does not have to be the intended target of the harassment, rather it can be anyone impacted by the offensive conduct. The Title IX Office appears to do a good job at handling concerns, rather Judicial Affairs seems to not hold people responsible.
